CORRECTION GRANT OF RECREATIONAL EASEMENT

THIS INDENTURE, made and entered into by and between the UNITED STATES OF AMERICA (hereinafter sometimes referred to as the "GRANTOR"), acting herein by and through its legal agent, the TENNESSEE VALLEY AUTHORITY (hereinafter sometimes referred to as "TVA"), a corporation created and existing under an Act of Congress known as the Tennessee Valley Authority Act of 1933, as amended, and TELLICO LAKE PROPERTIES, L.P., a Tennessee limited partnership, with TELLICO COMMUNITIES, INC., a Tennessee corporation, as the general partner (hereinafter referred to as the "GRANTEE");

WITNESSETH:

WHEREAS by Grant of Recreational Easement dated July 21, 1994, of record in Deed Book 218, page 544, in the office of the Register of Monroe County, Tennessee, and of record in Deed Book 214, page 310, in the office of the Register of Loudon County, Tennessee (hereinafter referred to as the "Grant"), and by Corrected Grant of Recreational Easement dated August 15, 1994, of record in Deed Book 219, page 414, in the office of the Register of Monroe County, Tennessee, and of record in Deed Book 215, page 435, in the office of the Register of Loudon County, Tennessee (hereinafter referred to as the "Corrected Grant"), GRANTOR acting by and through its legal agent, TVA, conveyed to GRANTEE a recreational easement as particularly described therein, and subject to the exceptions, reservations, restrictions, conditions, and/or limitations as set forth therein, affecting land designated in TVA's land records as TVA Tract No. XTELR-158RE; and

WHEREAS it has been determined that said Grant and said Corrected Grant failed to correctly describe the easement area; and

WHEREAS both GRANTOR and GRANTEE desire to correct the description of said easement area.

NOW, THEREFORE, in consideration of the premises and in order to correct said description, the UNITED STATES OF AMERICA, acting by and through TVA, has bargained and sold and by these presents does hereby transfer and convey unto the GRANTEE, a permanent easement and right-of-way for the following purposes, namely: the right to enter upon the hereinafter described easement area, and in accordance with plans approved in advance and in writing by TVA for private noncommercial recreation purposes with nonexclusive rights of ingress to and egress from the Tellico Reservoir, as specifically set forth in said Grant and Corrected Grant, all in, on, over, across, through, or under the easement area, as described in Exhibit A and shown on Exhibit B, both of which are attached hereto and made a part hereof.

TO HAVE AND TO HOLD said land and rights unto the GRANTEE, its successors and assigns forever.

And GRANTOR does hereby reaffirm and ratify all covenants, warranties, exceptions, reservations, restrictions, conditions, and/or limitations made and provided for in said Grant and Corrected Grant referenced above and the entire contents thereof, except for the incorrect description, as fully and effectively as if the entire instruments were copied herein verbatim containing the correct description, as set forth in said Exhibit A and shown on said Exhibit B, and said instruments are accordingly incorporated herein by reference.

EXHIBIT A

Thirteen parcels of land and a wildlife corridor lying in the First Civil District of Loudon County and Second Civil District of Monroe County, State of Tennessee, being opposite Little Tennessee River mile 14L of the Tennessee River as shown on US-TVA Drawing No. 65 MS 421 K 520-94D R.3 and being more particularly described as follows:

Wildlife Corridor

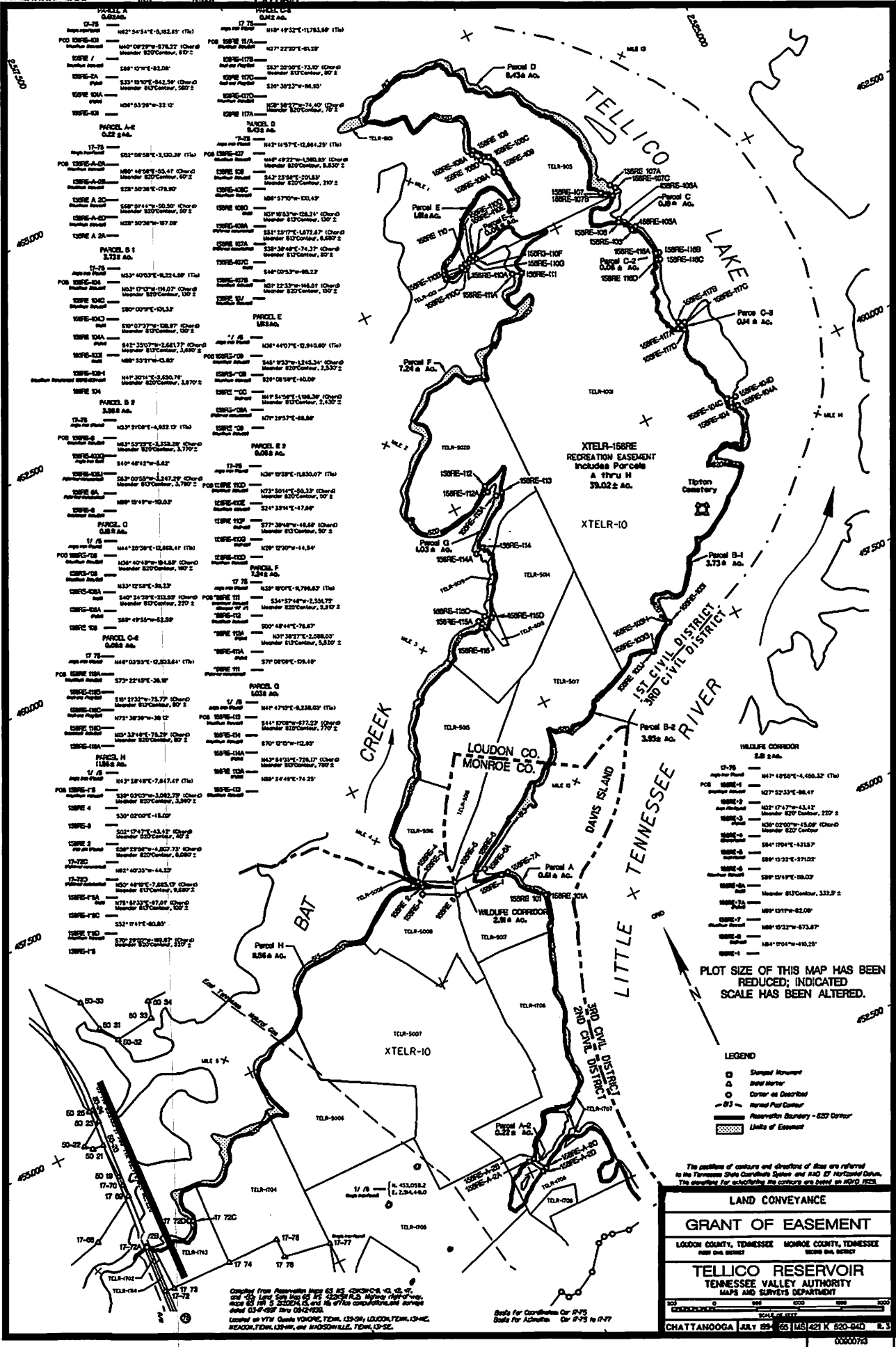
