### Did You Know? Wreaths Across America


- REMEMBER the Fallen. . . HONOR those who Serve. . . TEACH our children the value of Freedom.

- Chapter 11 Trustee Appointed Gary Murphey
- Lawyer for Trustee should be appointed/approved this week
- RBCAI has offered to hold townhall meeting for Trustee
  - Working on logistics and timing, etc
- September 11, 2025 is next court hearing
  - August 21, 2025 motions were continued till September 11, 2025
- Transcript of Bench Opinion due to Court by August 28, 2025
  - Judge will approve before its available on pacer

### **Bankruptcy – Proof of Claims (POC)**

- 326 POCs filed; asking for \$41,913,301.67
  - There appear to be some duplicates
- Interesting POCs on RBCAI website
  - Claims Register summary of all POCs filed
  - RBCAI 275 (assessments), 276 (lawn maintenance), 277 (assessments), 283 (lawn maintenance)
  - RBP 271
  - BEP (Bald Eagle) 264, 267, 268, 278,

# Lawsuits Update Lawsuits

#### Assessment – 20-489 (filed October 24, 2018 by RBCAI)

- Judge Bryant awarded attorney fees \$400,000+ to RBP
- Board has meeting with counsel to decide next steps

#### **Election – 21-173 (filed in August 27, 2020 by RBP)**

- Judge Bryant ruled RBP is entitled to some attorney fees
- Both RBP and RBCAI will have to file motion on amount

#### Partnership 19-943

- Tennessee Court of Appeals
- SPC filed their reply brief on August 1, 2025
- RBP reply brief due by September 5, 2025
- Oral arguments should be held in September/October timeframe
- $\circ$  Decision could be 5 6 months after oral arguments due to complexity of case
  - Spring of 2026
