As enacted, allows a student who earns the student's first baccalaureate degree in less than the projected completion time to continue to receive the Tennessee HOPE scholarship in pursuit of an advanced degree.
HB0029	289	Effective date(s) 07/01/2023	Amends TCA Title 49, Chapter 7. As enacted, authorizes a state university and the University of Tennessee system to coordinate with a two-year institution governed by the board of regents for the two-year institution to provide remedial or developmental courses or coursework, regardless of whether the university offers remedial or developmental courses or coursework at present.
HB0038	134	Effective date(s) 07/01/2023	Amends TCA Section 8-6-106. As enacted, specifies that when, in the judgment of the speaker of the house of representatives and the speaker of the senate, the interest of the state requires additional counsel to the attorney general and reporter, the speakers shall retain additional counsel to prosecute an action against the federal government on behalf of the state if the representation does not include payment of a fixed or contingent fee to any such additional counsel or otherwise increase state expenditures.
HB0040	369	Effective date(s) 07/01/2023	Amends TCA Title 43; Title 44; Title 47; Title 48 and Title 66. As enacted, prohibits certain foreign ownership of real property in this state by nonresident aliens and foreign entities if certain conditions are met.
HB0087	229	Effective date(s) 04/25/2023, 07/01/2023	Amends TCA Title 4; Title 47; Title 54; Title 55; Title 56; Title 65 and Title 66. As enacted, revises law relative to garagekeeper's or towing firm's liens, unclaimed or abandoned vehicles and notification of owners and lienholders, and motor vehicle storage.
HB0092	354	Effective date(s) 07/01/2023	Amends TCA Title 55, Chapter 8. As enacted, enacts the "Jabari Bailey Highway Safety Act," which requires drivers to change lanes or reduce speed upon approaching a stationary vehicle that has flashing hazard lights activated; increases fines for failing to change lanes or reduce speed upon approaching a stationary emergency, recovery, highway maintenance, solid waste, utility service, or other vehicle that has flashing lights activated.
HB0100	370	Effective date(s) 07/01/2023	Amends TCA Title 36, Chapter 1 and Title 67, Chapter 4, Part 6. As enacted, clarifies that a county continues to have the authority to levy a local litigation tax on an adoption proceeding in chancery, circuit, or juvenile court, and that the exemption does not limit or repeal such authority.

HB0155	372	Effective date(s) 05/11/2023, 01/01/2024	Amends TCA Title 68, Chapter 140, Part 3. As enacted, requires an annual training pay bonus supplement for eligible emergency medical services personnel in the amount of \$800.
HB0160	355	Effective date(s) 07/01/2023	Amends TCA Title 57, Chapter 3, Part 7. As enacted, makes changes to the requirements for applicants for server permits.
HB0163	373	Effective date(s) 07/01/2023	Amends TCA Title 36, Chapter 1; Title 37, Chapter 5 and Title 68, Chapter 11. As enacted, revises the definition of abandonment for purposes of termination of parental rights to include circumstances where the parent or guardian fails to visit or support the child for a period of three consecutive months if the child is less than four years of age.
HB0164	293	Effective date(s) 07/01/2023	Amends TCA Title 36, Chapter 1; Title 37, Chapter 5 and Title 68, Chapter 11. As enacted, authorizes a court to waive certain waiting periods and expedite certain proceedings relative to the adoption of children abandoned or voluntarily left at a facility or in a newborn safety device if certain conditions are met.
HB0187	294	Effective date(s) 07/01/2023	Amends TCA Title 20, Chapter 1, Part 1 and Title 56, Chapter 7, Part 12. As enacted, authorizes a plaintiff in certain civil actions filed against an owner and operator of an uninsured motor vehicle, where comparative fault is or becomes an issue, to amend the complaint to add certain persons as defendants or institute a separate action against such persons within a certain time following the filing of the first answer or first amended answer alleging such person's fault if such actions would otherwise be barred by the statute of limitations and other criteria is met.

As enacted, specifies that in general sessions court cases involving an order granting possession of real property, a writ of possession must issue by operation of law if no appeal is taken within the 10-day appellate period.

As enacted, specifies that municipal court has jurisdiction over the expunction of a person's conviction for a violation of a municipal ordinance from the public records; specifies conditions for such expunction.

HB0432	381	Effective date(s) 05/11/2023, 07/01/2023	Amends TCA Title 49. As enacted, enacts the "Tennessee Future Teacher Scholarship Act of 2023."
HB0448	300	Effective date(s) 07/01/2023	Amends TCA Title 8, Chapter 44, Part 1. As enacted, requires governmental entities to provide a period of public comment for public meetings; authorizes the governmental entities to place reasonable restrictions on the period for public comment.

As enacted, creates a Class A misdemeanor offense for the possession of a device, tool, machine, implement, or other item capable of programming a smart key or key fob with the intent to use it or allow it to be used to commit theft.
HB0554	237	Effective date(s) 07/01/2023	Amends TCA Title 8, Chapter 7; Title 16, Chapter 2 and Title 38, Chapter 6. As enacted, requires district attorneys general to designate one assistant district attorney general as the lead prosecutor in cases involving crimes committed against children; requires the Tennessee bureau of investigation to provide annual training to assistant district attorneys designated as lead prosecutors in crimes committed against children.
HB0562	360	Effective date(s) 07/01/2023	Amends TCA Title 58, Chapter 1. As enacted, clarifies that compensation for members of the national guard must accrue upon them being ordered to active state service and the payment of compensation to members must use this state's established weekly pay cycle as needed to effectuate compensation.
HB0577	306	Effective date(s) 07/01/2023	Amends TCA Title 39 and Title 40. As enacted, adds as a factor the court may consider for the purpose of enhancing a defendant's sentence upon conviction of a criminal offense, consideration of whether the defendant committed the offense of aggravated assault or attempted first degree murder on grounds or premises defined as a healthcare facility.
HB0606	361	Effective date(s) 07/01/2023	Amends TCA Title 29; Title 36; Title 37; Title 47 and Title 71. As enacted, makes various revisions to present law relative to adoption.
HB0702	386	Effective date(s) 07/01/2023	Amends TCA Title 39 and Title 40. As enacted, enacts the "One Pill Will Kill Act," which adds fentanyl, carfentanil, remifentanil, alfentanil, and thiafentanil to what constitutes a qualifying controlled substance for purposes of certain felony offenses.
HB0706	387	Effective date(s) 07/01/2023	Amends TCA Title 8, Chapter 36, Part 8. As enacted, makes changes to the present law relative to reemployment after retirement from public employment.

HB1193	242	Effective date(s) 07/01/2023	Amends TCA Title 39, Chapter 17. As enacted, broadens the offense of desecration of a venerable object by changing the culpable mental state from intentionally to recklessly or knowingly desecrating a place of worship or burial or a state or national flag.

As enacted, establishes a family medicine student loan repayment grant program to incentivize physicians in residency training to provide medical health services in health resource shortage areas following completion of their training.
HB1309	246	Effective date(s) 04/25/2023, 07/01/2023	Amends TCA Title 56, Chapter 7, Part 27. As enacted, prohibits a life insurance provider from canceling a life insurance policy based on genetic information, from requesting or requiring genetic testing as a condition of insurability, and from accessing the genetic data of an individual without consent.
HB1310	324	Effective date(s) 07/01/2023	Amends TCA Title 47. As enacted, enacts the "Genetic Information Privacy Act."
HB1342	415	Effective date(s) 07/01/2023	Amends TCA Title 4 and Title 50. As enacted, places certain restrictions on employers seeking to receive economic development incentives.
HB1444	416	Effective date(s) 07/01/2023	Amends TCA Title 38; Title 39; Title 40; Title 41 and Title 55. As enacted, makes changes to present law relative to criminal offenses involving motor vehicles.
HB1482	417	Effective date(s) 05/11/2023, 01/01/2025	Amends TCA Title 40, Chapter 11, Part 4. As enacted, allows the Tennessee Association of Professional Bail Agents to provide or contract for one or more virtual classes for agents; increases the maximum amount the association may charge for eight hours of continuing education; prohibits a person from attending such continuing education classes if the person has been convicted in any state of certain offenses.

SB0093	214	Effective date(s) 04/25/2023, 07/01/2023	Amends TCA Title 62, Chapter 3; Title 62, Chapter 4 and Title 62, Chapter 76. As enacted, creates an eyelash specialist license; authorizes the establishment of eyelash services shops in accordance with requirements for other licensed shops; authorizes schools to offer courses of instruction that consist of 50 percent of the hours needed for an eyelash specialist license to be obtained from apprenticeship; requires certain rule promulgation by the board of cosmetology and barber examiners.
SB0097	158	Effective date(s) 07/01/2023	Amends TCA Title 50, Chapter 6. As enacted, enacts the "Garrison-Jordan Survivor Benefits Act."

SB0105	422	Effective date(s) 05/11/2023, 01/01/2024	Amends TCA Title 55, Chapter 50. As enacted, requires the department of safety to waive the knowledge test, and accept alternative requirements, for active duty and honorably discharged service members and members of the national guard or the armed forces reserves applying for temporary commercial learner's permits; identifies certain alternative requirements, which include operating a commercial motor vehicle in the military in combination with a good driving record.
SB0125	183	Effective date(s) 01/01/2024	Amends TCA Section 3-1-102; Section 3-1-103 and Title 5, Chapter 2. As enacted, establishes a new boundary line between Shelby County and Fayette County.
